

### Play, Spin & Win Official Rules (“Official Rules”)

- Must be 18 or older on the date of entry to participate in the Play, Spin & Win promotion (“Promotion”) and a legal resident of the United States or the District of Columbia. A potential winner’s eligibility to claim a prize in the Promotion may be contingent upon the potential winner’s execution and return to the New Jersey Lottery or its designee of any forms that may be required by the New Jersey Lottery or its designee. A potential winner is required to present proper identification (e.g., valid Driver’s License or other documentation deemed proper and appropriate by the New Jersey Lottery or its designee) at the time and location required by the New Jersey Lottery or its designee in order to claim the prize. By participating in the Promotion, Entrant agrees to comply fully with all Official Rules and Entrant agrees to be bound by the Image Authorization and Waiver and Release of Liability.
- The Promotion will be held from August 27, 2020 through October 1, 2020. Specific Promotion dates, times and locations (each, a “Promotion Event”) will be posted to the New Jersey Lottery Website at: [NJLottery.com/QDEvents](http://NJLottery.com/QDEvents). Dates, times and locations are subject to change without notice in the discretion of the New Jersey Lottery or its designee.
- To enter the Promotion (referred to in these Official Rules as “Player” or “Participant” or “Entrant”), a Player must purchase a minimum of \$5.00 of Quick Draw at the Promotion Event and show his or her Quick Draw ticket(s) to the New Jersey Lottery Sales representative at the Promotion Event in order to receive one (1) spin of the Promotional Prize Wheel. One (1) spin of the Promotional Prize Wheel per person, per Promotion Event. The Promotional Prize Wheel will be spun by a New Jersey Lottery sales representative on behalf of each Player.
- Prize(s) reflected on the Promotional Prize Wheel tiles are subject to availability and are subject to change by the New Jersey Lottery or its designee without notice. If a prize reflected on the Promotional Prize Wheel is not available, a substitution of a like prize will be made. Cash shall not be awarded in lieu of prize. To the extent the prize includes tickets to a Live Nation produced and promoted concert, the following Live Nation Indemnification Provision shall apply. Tickets to a select 2020 Live Nation produced and promoted concert in the greater Philadelphia and New York markets. Selection of ticket type and/or concert seat location is solely within Live Nation’s discretion. Parking, travel and accommodations not included and are the sole responsibility of winner and guest(s). Winner and guest(s) must abide by all venue policies. Live Nation reserves the right to revoke full or partial prize from any winner or winner’s guest who it and/or venue personnel deem may, in their sole discretion, be intoxicated, be a safety risk, have violated any venue policy or law, and/or may bring Sponsor and/or Live Nation into disrepute. Resale of tickets is prohibited. Live Nation Marketing, Inc. is not a sponsor of the Promotion, and is no way responsible for the administration of the Promotion, the verification of winners or the fulfillment of prizing. - **Image Authorization.** By participating in the Promotion, the Entrant hereby irrevocably consents to the use of his/her name, town and state of residence, prize, photograph(s), video(s), voice, and likeness by the New Jersey Lottery and its agents, representatives and designees, in any and all of the New Jersey Lottery’s online, printed and social media advertisements, promotions, publications, illustrations, and other Web content throughout the world in perpetuity, including but not limited to, on the World Wide Web, without payment or any other consideration to the Entrant. The Entrant hereby irrevocably authorizes the New Jersey Lottery and its agents, representatives and designees to edit, alter, copy, exhibit, publish and/or distribute, without any inspection or approval of use by the Entrant, the Entrant’s name, town and state of residence, prize, photograph(s), video(s), voice, and likeness for purposes of publicizing the New Jersey Lottery or for any other lawful purpose. In addition, the Entrant hereby irrevocably waives any right to royalties or other compensation arising from or related to the use of the Entrant’s name, town and state of residence, prize, photograph(s), video(s), voice, and likeness. The Entrant hereby holds harmless and forever releases, discharges and indemnifies the New Jersey Lottery and Northstar New Jersey Lottery Group, LLC, and its/their respective agents, owners, operators, officers, directors, elected officials, members, shareholders, contractors, subcontractors, employees, partners, and designees, and each of their respective parent companies, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers and advertising and promotion agencies, and any and all other companies associated with the New Jersey Lottery and/or Northstar New Jersey Lottery Group, LLC, from any and all liability, injury, damage, death, litigation, claim, cause of action, loss or demand, known or unknown, which the Entrant, the Entrant’s heirs, agents, representatives, executors, administrators, or any other persons acting on the Entrant’s behalf or on behalf of the Entrant’s estate have or may have by reason of this Image Authorization, including without limitation, all claims for invasion of privacy, right of publicity, defamation, false endorsement, and any other claims regarding personal and/or property rights. The New Jersey Lottery Law ([N.J.S.A. 5:9-1 et seq.](#) and [N.J.A.C. 17:20-1 et seq.](#)) allows the holders of winning New Jersey Lottery tickets or shares to choose to remain anonymous. This does not apply to the Promotion.
- **Waiver and Release of Liability:** By participating in the Promotion, Entrant agrees to forever waive, discharge, indemnify and release the New Jersey Lottery and Northstar New Jersey Lottery Group, LLC, and its/their respective agents, owners, operators, officers, directors, elected officials, members, shareholders, contractors, subcontractors, employees, partners, and designees and each of their respective parent companies, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers and advertising and promotion agencies, and any and all other companies associated with the New Jersey Lottery and/or Northstar New Jersey Lottery Group, LLC (collectively “Affiliates”), from any and all liability, injury, damage, death, litigation, claim, cause of action or loss that may occur, directly or indirectly, whether known or unknown, and whether caused by negligence or not, arising out of or associated with Entrant’s participation in the Promotion, Entrant’s acceptance, possession, use or misuse of any Prize awarded in connection with

the Promotion, any defect with the Promotion, and/or any error in the administration or operation of the Promotion. The Entrant, on behalf of him/her self, his/her spouse, heirs, executors, administrators, representatives, successors, assigns and next of kin, waive all claims for damages, injuries and/or death, whether known or unknown, and whether caused by negligence or not, sustained to Entrant or Entrant's property that Entrant may have against the New Jersey Lottery and/or Northstar New Jersey Lottery Group, LLC, and its/their respective Affiliates, arising out of or associated with Entrant's participation in the Promotion, Entrant's acceptance, possession, use or misuse of any Prize awarded in connection with the Promotion, any defect with the Promotion, and/or any error in the administration or operation of the Promotion.

- The Official Rules may be changed at any time without prior notice if determined by the New Jersey Lottery or its designee to be in the best interests of the New Jersey Lottery.
- Payment of any and all federal, state and or local taxes associated with the prize awarded in connection with the Promotion shall be the sole obligation of the winner. Prizes exceeding \$599.50 require the submission of a claim form to the New Jersey Lottery. - By participating in the Promotion, participants agree to accept the decisions of the New Jersey Lottery or its designee as final and binding with regard to the Promotion.
- The invalidity or unenforceability of any provision of these Official Rules will not affect the validity or enforceability of any other provision of these Official Rules. In the event that any provision of these Official Rules is determined to be invalid or otherwise unenforceable or illegal, in whole or in part, the other provisions will remain in full force and effect and will be construed in accordance with their terms as if the invalid or illegal provision were not contained therein. The headings used in these Official Rules are for convenience only and shall not affect the interpretation of any of the provisions of these Official Rules. The failure to enforce any provision of these Official Rules will not constitute a waiver of that or any other provision of these Official Rules
- The Sponsor of the Promotion is the New Jersey Lottery, 1333 Brunswick Avenue, Trenton New Jersey 08648. The Promotion is governed by the State Lottery Law, N.J.S.A. 5:9-1 through -25, and the Rules of the Lottery Commission, N.J.A.C. 17:20-1.1 through -12.23. The New Jersey Lottery Executive Director has the sole authority to resolve disputes. The New Jersey Lottery Executive Director's decision regarding any disputes shall be final.
- The Promotion may be terminated, suspended or withdrawn at any time by the New Jersey Lottery or its designee without notice. The Promotion is void where prohibited or restricted by law.
