

**SUPPLEMENTAL OFFICIAL RULES FOR COLLECT 'N WIN
WINNING WEDNESDAY PROMOTION
Effective January 3, 2024**

The New Jersey Lottery is conducting an additional Collect 'N Win Winning Wednesday Promotion ("Collect 'N Win Winning Wednesday Promotion") whereby Participants who purchase and enter Eligible Draw Game Ticket(s) valued at \$1 or more on January 3, 2024 ("Eligible Ticket") are eligible to participate. The Promotion is governed by these Supplemental Official Rules for Collect 'N Win Promotion ("Supplemental Official Rules") and the "Official Rules for Collect 'N Win Yearlong Promotion" (Effective July 1, 2023 ("Official Rules"). To participate in the Promotion, Participants must have already Registered for a New Jersey Lottery VIP Club Account and may download the New Jersey Collect 'N Win app for iOS devices or direct download for Android devices, or by visiting NJCollectAndWin.com. For Registration details, visit <https://www.njlottery.com/en-us/secondchance/signup.html>. To the extent you access the Promotion on the New Jersey Lottery mobile application through an Apple device, please be advised that the Promotion is not associated with, sponsored, endorsed or administered by Apple.

Capitalized words used but not defined in these Supplemental Official Rules shall have the meanings ascribed to such words in the Official Rules.

1. The Promotion Period for the Promotion is defined as: approximately 05:00 AM January 3, 2024 – 11:59 PM January 3, 2024.
2. During the Promotion Period, Participants (sometimes referred to as "you" or "your") who enter an Eligible Ticket into Collect 'N Win will randomly be awarded one of the following on a per ticket basis:
 - One \$5 Instant Cash Voucher
 - One \$10 Instant Cash Voucher
 - One \$20 Instant Cash Voucher
3. During the Promotion Period, Participants (sometimes referred to as "you" or "your") who enter an Eligible Ticket into Collect 'N Win will receive entry for a chance to win the following prize:
 - One \$10,000 Winning Participant

I. CASH VOUCHERS:

1. Participants awarded one of the \$5 Instant Cash Vouchers, \$10 Instant Cash Vouchers, and/or \$20 Instant Cash Vouchers will instantly receive a voucher barcode that will be stored in their player account and can be accessed and redeemed immediately. To redeem one of the \$5 Instant Cash Vouchers, \$10 Instant Cash Vouchers, and/or \$20 Instant Cash Vouchers, you must present the Voucher Barcode to a New Jersey Lottery licensed retailer. A Voucher Barcode may be presented to a New Jersey Lottery licensed retailer via a mobile device or printed copy. \$5 Instant Cash Vouchers, \$10 Instant Cash Vouchers, and/or \$20 Instant Cash Vouchers are only valid for a single redemption.

All vouchers will expire on February 3, 2024. The New Jersey Lottery is not responsible for lost, stolen, damaged or expired vouchers.

2. Per the Official New Jersey Lottery Collect 'N Win Rules & Drawing Procedures, New Jersey Lottery licensed retailers are not eligible to participate in this Promotion. At the conclusion of the Promotion Period, the New Jersey Lottery may, at its sole discretion, conduct an audit to determine which player accounts received any of the \$5 Instant Cash Voucher, \$10 Instant Cash Voucher and/or \$20 Instant Cash Voucher.

HOW TO ENTER:

1. For each purchase of \$1 or more of an Eligible Ticket, a Participant will receive one entry into the Promotion. The Drawing Entry is automatically generated for the Participant and submitted for the applicable Drawing set forth in the Drawing Schedule in Section II of these Supplemental Official Rules.
2. Each Eligible Ticket is verified at time of entry generation to ensure it is eligible for the Promotion in accordance with the requirements of these Supplemental Official Rules.
3. Once a Drawing Entry has been created, it will be given a unique sequential number and stored in a secured electronic file until the applicable End Submission Date noted in the Drawing Schedule in Section II of these Supplemental Official Rules.
4. It is recommended but NOT required that Participants save their physical Eligible Tickets if needed to submit as verification once they are entered online or via the Lottery or Collect 'N Win app.
5. There will be no limit to the number of entries submitted by a Participant during the Promotional Period.

ELIGIBLE DRAWING ENTRIES

1. Each entry and subsequent Drawing Entry in the Promotion must be completed via NJLottery.com or NJCollectAndWin.com or via the Lottery app, or the Collect 'N Win app., and each entry and subsequent Drawing Entry in the Promotion must meet all eligibility requirements set forth in these

Supplemental Official Rules. Each Eligible Ticket barcode number can only be scanned or entered one time in the Promotion. Drawing Entries that include tickets with invalid ticket numbers or tickets that have been canceled will be disqualified from the applicable Drawing or Drawings. Drawing Entries received after the final Entry Submission End Date will not be eligible for any Drawing or prize. The odds of winning depend on the number of Drawing Entries complying with these Supplemental Official Rules submitted in the Drawing. All Drawing Entries are subject to validation by Alchemy3, Northstar and the Lottery and may be disqualified without notice if eligibility requirements are not met.

2. The Promotion is only for individual Participants. If the name or address of any selected Drawing Entry matches any name or address listed on an official Agent Lottery License, the Drawing Entry will be disqualified.

RANDOM SELECTION OF DRAWING ENTRIES IN DRAWINGS

1. Alchemy3 shall conduct one individual Drawing during the Promotional Period in accordance with the Draw Schedule listed in Section II of these Supplemental Official Rules.
2. The Draw will be conducted by use of a certified Random Number Generator ("RNG") program to select a combined total of eleven Drawing Entries Alternate Drawing Entries. The Drawing during the Promotional Period shall be observed and certified by an independent auditor.
3. Subject to further conditions below, the prize shall be awarded in connection with the Drawing during the Promotion Period in the following manner:
 - a. The first one eligible Drawing Entry that is drawn will be awarded a \$10,000 Cash Prize.
 - b. The next ten eligible Drawing Entries that are drawn will be deemed Alternate Entries.
4. In the event that any Drawing Entry drawn is disqualified or deemed ineligible, an Alternate Drawing Entry will be awarded the prize, in the order such Alternate Drawing Entry is drawn. In order for an Alternate Drawing Entry to receive a prize, the Alternate Drawing Entry must be in full compliance with these Supplemental Official Rules. The Lottery shall make the ultimate determination as to disqualifications and ineligibility. Drawing Entries and Alternate Drawing Entries that are not selected in a particular Drawing will NOT roll or carry over to any other Draw during the Promotional Period.
5. Winner contact information will be pulled directly from the Drawing Entry file containing Participant Information provided when registering for an account. Failure to include any of the required Participant Information, or failure to keep all Participant Information current and accurate, may result in forfeiture of a prize and/or a claim being denied. The Lottery, Northstar and/or Alchemy3, and/or its/their respective officers, directors, employees, agents or members, shall not have any liability for a Participant's failure to receive a prize or other notification caused by, among other things, the Participant's spam, junk e-mail or other security settings or for a Participant's provision of incorrect, non-functioning or out of date Participant Information.
6. For all prizes, only one prize, the \$5,000 Yearlong monthly prize, or the \$500 Yearlong monthly prize, or the Winning Wednesday \$10,000 prize, may be won per Winning Participant or household per the Yearlong Promotional Period.

a. The Winning Participant who wins the \$10,000 prize will be ineligible to win any \$5,000 prize(s) or \$500 prize(s) for the remaining duration of the Yearlong Promotional Period. The \$10,000 Winning Participant residing in the same household or who shares the same address as a previous \$5,000 winner or a previous \$500 winner is disqualified from winning the \$10,000 prize and also disqualified from winning a \$5,000 prize and a \$500 prize for the remaining duration of the Yearlong Promotional Period. During the Promotional Period, if a potential winning Drawing Entry from a household or address with a prior \$5,000 winning Drawing Entry or a prior \$500 winning Drawing Entry is selected during the Promotional Period, that Drawing Entry will be disqualified and replaced with an Alternate Drawing Entry. Disqualifications are subject to Section V in these Supplemental Official Game Rules.

WINNING PARTICIPANT VALIDATION

1. After the drawing is complete, Participant validation will proceed according to the following steps:

- a. Alchemy3 will provide Northstar's designated contact person with the list of the combined total of eleven Drawing Entry and Alternate Drawing Entries to check for eligibility. Within approximately ten business days, the Lottery will review the list of Drawing Entry and Alternate Drawing Entries and notify Northstar when the winning Drawing Entry is approved to post.
- b. The potential winning Drawing Entry and the Alternate Drawing Entries will be reviewed to verify that each selected Drawing Entry is valid and that the Participant with potential winning Drawing Entry or Alternate Drawing Entries satisfy the eligibility requirements set forth in these Supplemental Official Rules.
- c. A report by an independent auditor certifying that the Drawing was conducted in accordance with the procedures set forth in these Supplemental Official Rules will be supplied by Alchemy3 to Northstar and the Lottery within approximately two business days after the Drawing.
- d. Northstar will notify Alchemy3 that the Participant with the winning Drawing Entry has been cleared and satisfy the requirements of these Supplemental Official Rules.
- e. Alchemy3 will post the Participant with the winning Drawing Entry's First Name, Last Name, and City and State of residence to the Collect 'N Win promotional website within approximately two business days of receipt of confirmation from Northstar that the Participant with the winning Drawing Entry or Alternate Drawing Entry meets the winner eligibility requirements set forth in these Supplemental Official Rules.

\$10,000 WINNING PARTICIPANT NOTIFICATION/FULFILLMENT

1. Once the winning Participant has been approved and is posted to the Collect 'N Win promotional website, the following steps will occur:

- a. The Lottery will contact the Participant with the potentially winning Drawing Entry or Alternate Drawing Entry selected for the \$10,000 Prize using the Participant Information provided in the Participant's account and will send a winner notification letter including a form to complete and return that will request the Participant to submit his/her Social Security Number for verification to the Lottery within 30 days after notification.
- b. Returned forms will be reviewed by the Lottery to verify that the Participant with a potentially winning Drawing Entry or Alternate Drawing Entry selected to win a prize in

the Promotion meets the winner eligibility requirements set forth in these Supplemental Official Rules. If neither the selected Drawing Entry nor the Alternate Drawing Entry are verified as a Prize winner, or the Participant with the selected Drawing Entry or Alternate Drawing Entry fails to submit their completed winner notification form, Lottery claim form, and/or provide any other information or documentation requested or required by the Lottery within 30 days of receiving a winner notification email by the Lottery, another Alternate Drawing Entry will be selected and will be reviewed to verify that each selected Drawing Entry is valid and that the Participant with potential winning Alternate Drawing Entry satisfies the eligibility requirements set forth in these Supplemental Official Rules.

c. The Lottery will provide Alchemy3 and Northstar with a fulfillment spreadsheet containing the Participant with winning Drawing Entry selected in the Drawing conducted during the Promotional Period that Lottery has approved for fulfillment.

d. Additionally, the Winning Participant of a \$10,000 prize will be checked for setoffs, and any debt owed to the State of New Jersey will be deducted and withheld from the prize.

e. The Lottery will inform Northstar and Alchemy3 when the prize can be fulfilled.

f. Alchemy3 will fulfill the prize and send payment directly to each Winning Participant.

g. The \$10,000 cash prize will be delivered to the Winning Participant via check. Each Winning Participant's information will be confirmed on the winner fulfillment spreadsheet.

III. TAXES AND DEBTS OWED TO STATE

1. Prize(s) may be subject to federal tax, including withholding tax, and New Jersey tax, including withholding tax, at the prevailing tax rates. In addition, prize(s) may be subject to garnishment per N.J.S.A. 5:9-13.5, 13.14, and 13.17 in accordance with the procedures set forth in N.J.A.C. 17:42-1.1 et seq. and N.J.A.C. 17:43-1.1 et seq.

2. If a Winning Participant is identified as owing an outstanding debt to a State agency or child support collected through a court, the value of the prize may be offset and applied to the Winning Participant's obligations in accordance with the applicable laws of the State of New Jersey. The remaining balance after garnishments, if any, will be awarded to the Winning Participant. If the Winning Participant is able to immediately (within a period of time determined by the Lottery in its sole discretion) and independently satisfy any such debt, the Lottery will not pursue prize garnishment upon proof of satisfaction.

3. A federal withholding tax rate of 30% shall be withheld from any prize of \$600 or more paid to the Winning Participant who does not furnish a taxpayer identification (social security) number.

a. Alchemy3 shall deposit any withholdings on behalf of the prize winner to the appropriate agency and issue the proper IRS form W-2G to the Winning Participant and a copy of the form shall be provided to the New Jersey Lottery.

4. Winning Participants are solely responsible for payment of all applicable federal, State and local taxes associated with any prize awarded in connection with the Promotion.

IV. ODDS AND OTHER RESTRICTIONS

Odds of winning any prize depend upon the number of Drawing Entries submitted for the Drawing in compliance with these Supplemental Official Rules during the Promotional Period. Prizes are not transferable.

V. DISPUTES

The Promotion is governed by the State Lottery Law, N.J.S.A. 5:9-1 through -25, and the Rules of the Lottery Commission, N.J.A.C. 17:20-1.1 through -12.23. The Lottery's Executive Director has the sole authority to resolve disputes. The Lottery's Executive Director's decision regarding any disputes shall be final.

VI. IMAGE AUTHORIZATION

By participating in the Promotion, the Participant hereby irrevocably consents to the use of his/her name, town and state of residence, prize, photograph(s), video(s), voice, and/or likeness (collectively "Image") by the Lottery and its agents, representatives and designees in any and all of the New Jersey Lottery's online, printed and social media advertisements, promotions, publications, illustrations, and other Web content throughout the world in perpetuity, including but not limited to, on the World Wide Web, without payment or any other consideration to the Participant. The Participant hereby irrevocably authorizes the Lottery and its agents, representatives and designees to edit, alter, copy, exhibit, publish and/or distribute, without any inspection or approval of use by Participant Participant's Image for purposes of publicizing the New Jersey Lottery or for any other lawful purpose. In addition, Participant hereby irrevocably waives any right to royalties or other compensation arising from or related to the use of Participant's Image. Participant hereby holds harmless and forever releases, discharges and indemnifies the New Jersey Lottery, Alchemy3, and Northstar New Jersey Lottery Group, LLC, and its/their respective agents, owners, operators, officers, directors, commissioners, elected officials, members, shareholders, contractors, subcontractors, employees, partners, and designees, and each of their respective parent companies, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers and advertising and promotion agencies, and any and all other companies associated with the New Jersey Lottery, Alchemy3 and/or Northstar New Jersey Lottery Group, LLC (collectively "Affiliates"), from any and all liability, injury, damage, death, litigation, claim, cause of action, loss or demand, known or unknown, which Participant, Participant's heirs, agents, representatives, executors, administrators, or any other persons acting on Participant's behalf or on behalf of Participant's estate have or may have by reason of this Image Authorization, including without limitation, all claims for invasion of privacy, right of publicity, defamation, false endorsement, and any other claims regarding personal and/or property rights. Participants must be 18 years or older, competent to contract in his/her own name and a legal resident of the United States or District of Columbia to play and participate in the Promotion. Persons prohibited from purchasing New Jersey Lottery tickets or shares pursuant to N.J.S.A. 5:9-16 and N.J.A.C. 17:20-1.3 are prohibited from playing or participating in the Promotion. Participant acknowledges that the Lottery Law (N.J.S.A. 5:9-1 et seq. and N.J.A.C. 17:20- 1.1 et seq.) allows the holders of winning Lottery tickets or shares to choose to remain anonymous and Participant acknowledges that this does not apply to the Promotion.

VII. WAIVER AND RELEASE

By participating in the Promotion, Participant agrees to forever waive, discharge, indemnify and release the New Jersey Lottery, Alchemy3 and Northstar New Jersey Lottery Group, LLC, and its/their respective "Affiliates"), from any and all liability, injury, damage, death, litigation, claim, cause of action or loss that may occur, directly or indirectly, whether known or unknown, and whether caused by negligence or not, arising out of or associated with Participant's participation in the Promotion, Participant's acceptance, possession, use or misuse of any prize awarded in connection with the Promotion, any defect with the Promotion, and/or any error in the administration or operation of the Promotion. Participant, on behalf of him/herself, his/her spouse, heirs, executors, administrators, representatives, successors, assigns and next of kin, waive all claims for damages, injuries and/or death, whether known or unknown, and whether caused by negligence or not, sustained to Participant or Participant's property, that Participant may have against the New Jersey Lottery, Alchemy3 and Northstar New Jersey Lottery Group, LLC, and its/their respective Affiliates, arising out of or associated with Participant's participation in the Promotion, Participant's acceptance, possession, use or misuse of any prize awarded in connection with the Promotion, any defect with the Promotion, and/or any error in the administration or operation of the Promotion.

By participating in the Promotion, New Jersey Lottery licensed retailers and Participants agree to fully comply with these Supplemental Official Rules and to accept the decisions of the New Jersey Lottery or its designee as final and binding with regard to the Promotion. The Promotion is governed by the State Lottery Law, N.J.S.A. 5:9-1 through -25, and the Rules of the Lottery Commission, N.J.A.C. 17:20-1.1 through -12.23. The New Jersey Lottery Executive Director has the sole authority to resolve disputes. The New Jersey Lottery Executive Director's decision regarding any disputes shall be final.

VIII. PROMOTION INTEGRITY

The Lottery reserves the right to cancel, terminate, modify or suspend the Promotion for any reason, including but not limited to if it determines, in its sole discretion, that a virus, bug, unauthorized human intervention, fraud or other cause beyond its control or the control of its Affiliates (the "Event") has or is corrupting or affecting the administration, security, fairness or proper conduct of the Promotion. In the case of an Event, the New Jersey Lottery, in its sole discretion, may select Winning Participants from all eligible entries received prior to or after resolution of (if appropriate) the Event. The Lottery reserves the right, in its sole discretion, to disqualify any individual who tampers with or attempts to tamper with the entry process for the Promotion, the operation of the Promotion or otherwise violates these Official Rules. The Lottery or its designee has the right, in its sole discretion, to maintain the integrity of the Promotion and to void a Drawing Entry for any reason, including the use of bots, macros or scripts or other technical means for entering.

X. SEVERABILITY; WAIVER; HEADINGS

In the event that any provision of these Supplemental Official Game Rules is determined to be invalid or otherwise unenforceable or illegal, in whole or in part, the other

provisions will remain in full force and effect and will be construed in accordance with their terms as if the invalid or illegal provision were not contained therein. The headings used in these Supplemental Official Game Rules are for convenience only and shall not affect the interpretation of any of the provisions of these Official Game Rules. The failure to enforce any provision of these Official Game Rules will not constitute a waiver of that or any other provision of these Supplemental Official Game Rules.

All winners, tickets and transactions in connection with the Promotion are subject to New Jersey Lottery Rules and Regulations and State law. All prizes awarded in connection with the Promotion may be subject to claim procedures, validation tests and other applicable requirements of the New Jersey Lottery. Liability for void or nonconforming ticket, if any, is limited to replacement of ticket with un-played ticket. The New Jersey Lottery is not responsible for lost or stolen tickets. The Promotion is void where otherwise prohibited by law. The Promotion is not valid in combination with any other New Jersey Lottery promotion or coupon. The New Jersey Lottery may declare any Eligible Ticket purchased during the Promotion Period void if it is stolen.

These Supplemental Official Rules may be changed at any time without prior notice if determined, in the sole discretion of the New Jersey Lottery or its designee to be in the best interests of the New Jersey Lottery.
