



RULES FOR THE PICK-3 GREEN BALL PROMOTION
Effective July 6, 2026

1. OVERVIEW:

The New Jersey Lottery (“Lottery”) is conducting a Pick-3 Green Ball Promotion (“Pick-3 Promotion” or “Green Ball Promotion”) on July 6, 2026, through August 2, 2026. After the Lottery draws the evening Pick-3 winning numbers, a subsequent drawing will be conducted from a separate draw machine that contains six white balls and one green ball. If the green ball is drawn, a bonus (second) set of Pick-3 winning numbers will be drawn. If a white ball is drawn, it will be removed, and at the next scheduled evening drawing, another drawing will be held from the remaining white balls and green ball. A white ball will be removed each evening draw until the green ball is selected. Once the green ball is selected and after the second set of Pick-3 numbers are drawn, all seven (7) balls are replaced for the next scheduled evening Pick-3 drawing during the Promotional Period (as defined herein).

2. GAME PLAY:

- a. In order to participate in the Green Ball Promotion, Players (sometimes referred to as “you” or “your” or “players”) must purchase an “Eligible Ticket,” defined as a Pick-3 ticket, with or without the Fireball option, purchased at a New Jersey Lottery licensed retail location or through a registered courier service for drawings taking place during the Promotional Period, or a Pick-3 multi-draw ticket with drawings scheduled to take place during the Promotional Period.

3. DRAWINGS:

- a. During the Promotional Period, the Lottery draws the evening Pick-3 winning numbers as usual. Immediately following, a subsequent drawing will be conducted from a separate draw machine that contains six white balls and one green ball (“Green Ball Machine”).
- b. If a white ball is drawn, that one white ball will be removed from the Green Ball Machine. After the next day’s evening Pick-3 drawing, a subsequent drawing will again be conducted using the remaining white balls (five, four, three, two, or one) and one green ball. A white ball will be removed each time it is drawn from the Green Ball Machine until the green ball is selected.
- c. When the green ball is drawn from the Green Ball Machine, a second set of Pick-3 numbers will be drawn (“Green Ball Double Draw”) and players will have a bonus (second) chance to win from their same Pick-3 wager. The prize structure for the second set of Pick-3 numbers is unchanged. If a Pick-3 wager was purchased with the Fireball option, the base wager is eligible for the green ball promotion however the Fireball will NOT be included in the winner determination. The Fireball

number will apply only to the original Pick-3 drawing and will not apply to the Green Ball Double Draw numbers.

- d. The Pick-3 Green Ball Double Draw numbers will be drawn from the same Pick-3 draw machine as the first set of Pick-3 numbers, with three chambers containing numbers 0-9. To do so, the three balls selected from the regularly scheduled evening Pick-3 drawing are returned to the chambers and remixed, such that the full matrix of Pick-3 numbers are used for the Green Ball Double Draw.
- e. Once the green ball is selected, and after the Pick-3 Green Ball Double Draw numbers are drawn, all six white balls and one green ball will be added back to the Green Ball Machine for the next evening Pick-3 drawing. The Green Ball is statistically certain to be drawn at least four times during the Promotional Period.
- f. To the extent the Pick-3 Promotion is accessed on the New Jersey Lottery mobile application through an Apple device, the Pick-3 Promotion is not associated with, sponsored, endorsed or administered by Apple.

4. PROMOTION RULES:

- a. The Promotional Period for the Pick-3 Promotion is defined as: between the hours of 5 a.m. Monday, July 6, 2026 – approximately 10:57 p.m. Sunday, August 2, 2026 (“Promotional Period”).
- b. The Pick-3 Promotion is governed by the “Official Game Rules for Pick-3” effective November 14, 2022, as supplemented by these rules for the Pick-3 Promotion. Unless otherwise defined or the context clearly indicates otherwise, all capitalized terms used in the Pick-3 Green Ball Promotion shall have the same meaning as defined in the Official Pick-3 Game Rules.

5. PROMOTION PRIZE STRUCTURE:

- a. The regular Pick-3 evening drawing and any Green Ball Double Draw drawing follow the Prize Payout and Structure as outlined in the “Official Game Rules for Pick-3” effective November 14, 2022.
- b. The Fireball number will only apply to the original Pick-3 drawing and will not apply to the Green Ball Double Draw numbers.

6. PARTICIPATION STANDARDS:

- a. Players must be 18 years or older to play and participate in the Pick-3 Promotion. Persons prohibited from purchasing New Jersey Lottery tickets or shares pursuant to N.J.S.A. 5:9-16 and N.J.A.C. 17:20-1.3 are prohibited from playing or participating in the Pick-3 Promotion.



- b. By participating in the Pick-3 Promotion, you agree to forever waive, discharge, indemnify and release the New Jersey Lottery and Northstar New Jersey Lottery Group, LLC, and its/their respective agents, owners, operators, commissioners, officers, directors, elected officials, members, shareholders, contractors, subcontractors, employees, partners, and designees and each of their respective parent companies, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers and advertising and promotion agencies, and any and all other companies associated with the New Jersey Lottery and Northstar New Jersey Lottery Group, LLC (collectively "Affiliates"), from any and all liability, injury, damage, death, litigation, claim, cause of action or loss that may occur, directly or indirectly, whether known or unknown, and whether caused by negligence or not, arising out of or associated with your participation in the Pick-3 Promotion, your acceptance, possession, use or misuse of any prize awarded in connection with the Pick-3 Promotion, any defect, failure or tampering with the Pick-3 Promotion, and/or any error in the administration, drawing, or operation of the Pick-3 Promotion.
- c. By participating in the Pick-3 Promotion, New Jersey Lottery licensed retailers and Players agree to fully comply with these Official Rules and to accept the decisions of the New Jersey Lottery, or its designee, as final and binding with regard to the Pick-3 Promotion.

7. LIABILITY OF THE LOTTERY:

- a. The Pick-3 Promotion is offered at New Jersey Lottery licensed retail locations listed as "Active" in the New Jersey Lottery's Gaming System during the Promotional Period. The New Jersey Lottery reserves the right in its discretion to add or remove New Jersey Lottery licensed retail locations to this "Active" list throughout the Promotional Period.
- b. The New Jersey Lottery may declare any Pick-3 ticket purchased during the Promotional Period void if it is damaged or stolen.
- c. The New Jersey Lottery reserves the right to adjust, make exceptions for and disqualify any New Jersey Lottery licensed retailer from participating in the Pick-3 Promotion at any time during the Promotional Period as deemed necessary by the New Jersey Lottery, in its discretion, to ensure the integrity of the Pick-3 Promotion and/or when such action is determined by the New Jersey Lottery, in its discretion, to be in the best interest of the New Jersey Lottery.
- d. The New Jersey Lottery reserves the right, without prior notice, to cancel, terminate, modify or suspend the Pick-3 Promotion at any time and for any reason, including but not limited to: if the prize payout exceeds the Pick-3 Promotion budget and if the New Jersey Lottery determines that a virus, bug, unauthorized human intervention, fraud or other cause beyond its control has or is corrupting or affecting the administration, security, fairness or proper conduct of the Pick-3 Promotion.
- e. The Pick-3 Promotion is governed by the State Lottery Law, N.J.S.A. 5:9-1 through -25, and the Rules of the Lottery Commission, N.J.A.C. 17:20-1.1 through -12.23. The New Jersey Lottery Executive Director has the sole authority to resolve disputes. The New Jersey Lottery Executive Director's decision regarding any disputes shall be final.



- f. These Official Rules may be changed at any time without prior notice if determined by the New Jersey Lottery or its designee to be in the best interests of the New Jersey Lottery.
- g. The invalidity or unenforceability of any provision of these Official Rules will not affect the validity or enforceability of any other provision of these Official Rules. In the event that any provision of these Official Rules is determined to be invalid or otherwise unenforceable or illegal, in whole or in part, the other provisions will remain in full force and effect and will be construed in accordance with their terms as if the invalid or illegal provision were not contained therein. The failure to enforce any provision of these Official Rules will not constitute a waiver of that or any other provision of these Official Rules.

8. CLAIMS AND VALIDATIONS

- a. All winners, tickets and transactions in connection with the Pick-3 Promotion are subject to New Jersey Lottery Rules and Regulations and State law. All prizes awarded in connection with the Pick-3 Promotion are subject to claim procedures, validation tests and other applicable requirements of the New Jersey Lottery. Liability for void or nonconforming ticket, if any, is limited to replacement of ticket with un-played ticket. Neither the New Jersey Lottery nor Northstar New Jersey Lottery Group, LLC is responsible for lost or stolen tickets. The Pick-3 Promotion is void where otherwise prohibited or restricted by law. The Pick-3 Promotion is not valid in combination with any other New Jersey Lottery promotion or coupon.
- b. Winners are solely responsible for payment of all applicable federal, State and local taxes associated with any prize awarded in connection with the Pick-3 Promotion.
- c. Pursuant N.J.S.A. 5:9-7b, holders of winning New Jersey Lottery tickets or shares may choose to remain anonymous indefinitely. The identity of a holder choosing to remain anonymous shall not be included under materials available for public inspection pursuant to the New Jersey Open Public Records Act (N.J.S.A. 47:1A-1 et seq.). Holders of winning tickets or shares may expressly authorize use by or on behalf of the New Jersey Lottery of his or her name, address, prize amount and photographic or videographic likeness, in any medium for the sole purpose of advertising and publicity.

9. RETAILER REQUIREMENTS, COMMISSIONS AND BONUSES:

- a. By participating in the Pick-3 Promotion, New Jersey Lottery licensed retailers agree to fully comply with these Official Rules and to accept the decisions of the New Jersey Lottery or its designee as final and binding with regard to the Pick-3 Promotion.
- b. All Retailers paying out cash Prizes up to \$599.00 shall receive a commission equal to 1.25% of the money paid out in Prizes.
