By participating in the New Jersey Lottery Tell Us Your Lottery Story and submitting the Tell Us Your Story form I hereby grant the New Jersey Lottery and Northstar New Jersey Lottery Group, LLC, and its/their respective agents, representatives and designees, the irrevocable right and permission to film, videotape, photograph and/or record me, to reproduce, publish, distribute, display, broadcast and/or use my image, likeness, voice, recording(s), video(s), photograph(s), name, actual and/or paraphrased statements, biographical information, town and state of residence, prize, prize amount and/or any other information or attribute identifying and/or otherwise associated with me (collectively "Image and Likeness"), in whole or in part, distorted, altered, modified, and/or adapted in character and/or in form, alone and/or accompanied by other material, in any manner and without restriction, worldwide in perpetuity, royalty-free and without compensation, and without inspection or approval of use by me, for any purpose whatsoever, including without limitation for the purposes of advertising, publicity, promotion, and/or other marketing of or on behalf of the New Jersey Lottery, in all media now known or hereafter developed (including but not limited to social media channels/platforms, other social media websites or applications, the Worldwide Web, television, radio and/or printed material).

I hereby hold harmless and forever release, discharge and indemnify the New Jersey Lottery and Northstar New Jersey Lottery Group, LLC, and its/their respective agents, owners, operators, officers, directors, commissioners, elected officials, members, shareholders, affiliates, contractors, subcontractors, employees, partners, and designees, and each of their respective parent companies, affiliated companies, subsidiaries and licensees, and any and all other companies associated with the New Jersey Lottery and Northstar New Jersey Lottery Group, LLC, from any and all liability, injury, damage, death, litigation, claim, cause of action, loss or demand, known or unknown, which I, my heirs, agents, representatives, executors, administrators, or any other persons acting on my behalf or on behalf of my estate have or may have by reason of this New Jersey Lottery Tell Us Your Lottery Story Image Authorization and Waiver and Release, my submission of the Tell Us Your Story form and/or the use of my Image and Likeness, including without limitation all claims for invasion of privacy, right of publicity, defamation, false endorsement, and any other claims regarding personal and/or property rights.

I understand that the New Jersey Lottery Law (N.J.S.A. 5:9-1 et seq. and N.J.A.C. 17:20-1.1 et seq.) ("New Jersey Lottery Law") allows the holders of winning New Jersey Lottery tickets or shares to choose to remain anonymous, and to the extent this applies to the New Jersey Lottery Tell Us Your Lottery Story in which I am participating, by clicking the box on the New Jersey Lottery Website indicating "I have read, understand and consent to the terms of the New Jersey Lottery's Waiver and Release", I hereby knowingly waive my right to remain anonymous under the New Jersey Lottery Law.
