



Official Rules for the New Jersey Lottery “Game Changers Monthly Sweepstakes (“Sweepstakes”)”:

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

Sweepstakes Period: July 1, 2021, at 12:00 a.m. ET to June 30, 2022 at 11:59 p.m. ET.

In accordance with the Sweepstakes Chart contained in these Official Rules, ten (10) winners will be selected each month during the Sweepstakes Period by a random computerized drawing of all entries submitted in compliance with these Official Rules and notified of their selection by the New Jersey Lottery or its designee. All randomly selected and announced winners are subject to verification by the New Jersey Lottery or its designee as set forth in these Official Rules. As set forth in the Finalist Selection and Verification section of these Official Rules, each randomly selected winner shall be required to provide his/her name, home address, email address and birth date, verify his/her full compliance with these Official Rules and provide such other information and documentation as may be required by the New Jersey Lottery or its designee (collectively “Claim Information”). As a condition of entering the Sweepstakes, entrants agree to be subject to and comply fully with the Sweepstakes Official Rules, and entrants agree to be bound by the Image Authorization and Waiver and Release of Liability contained in these Official Rules.

Prizes: For each month during the Sweepstakes Period, ten (10) randomly selected and verified winners will each receive one (1) \$10 Scratch-Offs Ticket (the “Prize”) selected by the New Jersey Lottery or its designee. The New Jersey Lottery or its designee reserves the right, without notice, to substitute the Prize with an alternative prize of equal value.

Eligibility: Must be at least 18 years of age and a registered member of the New Jersey Lottery’s Game Changers (“Game Changers”) community on the date of entry. To join the Game Changers community register at njgamechangers.com. Open only to legal residents of the United States of America and the District of Columbia. Employees and their immediate families living in the same household of the New Jersey Lottery, Northstar New Jersey Lottery Group, LLC, IGT Global Solutions Corporation, Scientific Games International, Inc., their direct vendors and their advertising agencies are not eligible to participate in the Sweepstakes.

Entry Rules: Each month during the Sweepstakes Period, surveys will be emailed to registered Game Changers members. To enter the Sweepstakes for a particular month, a registered Game

Changers member complying with these Official Rules must submit a completed Game Changers Survey (“Survey Submission”) prior to the Survey Submission End Date noted in the chart below. The Survey Submission will equal one (1) Sweepstakes entry for the Sweepstakes drawing scheduled to take place for that particular month during the Sweepstakes Period. Limit one (1) entry per person, per month, during the Sweepstakes Period. The Survey Submission End Date, Drawing Dates and Notification Dates for each month of the Sweepstakes Period (“Sweepstakes Chart”) are as follows and are subject to change without notice in the discretion of the New Jersey Lottery or its designee:

fraudulent, potentially fraudulent, or unusual behavior or activity, may be disqualified without notice in the sole discretion of the New Jersey Lottery or its designee. All decisions with regard to the Sweepstakes, including these Official Rules, made by the New Jersey Lottery or its designee, shall be final. No purchase necessary to enter or win. A purchase will not increase your chance of winning. The Sweepstakes shall be void where prohibited or restricted by law. The Sweepstakes is subject to all applicable federal, state and local laws and regulations. Winners will be subject to all applicable New Jersey State, federal and local laws and regulations. To the extent you access the Sweepstakes on the New Jersey Lottery mobile application through an Apple device, please be advised that the Sweepstakes is not associated with, sponsored, endorsed or administered by Apple.

Image Authorization:

As a condition of entering the Sweepstakes, the entrant hereby irrevocably consents to the use of his/her name, town and state of residence, Prize, photograph(s), video(s), voice, and likeness by the New Jersey Lottery and its agents, representatives and designees, in any and all of the New Jersey Lottery's online, printed and social media advertisements, promotions, publications, illustrations, and other Web content throughout the world in perpetuity, including but not limited to, on the World Wide Web, without payment or any other consideration to the entrant. The entrant hereby irrevocably authorizes the New Jersey Lottery and its agents, representatives and designees to edit, alter, copy, exhibit, publish and/or distribute, without any inspection or approval of use by the entrant, the entrant's name, town and state of residence, Prize, photograph(s), video(s), voice, and likeness for purposes of publicizing the New Jersey Lottery or for any other lawful purpose. In addition, the entrant hereby irrevocably waives any right to royalties or other compensation arising from or related to the use of the entrant's name, town and state of residence, photograph(s), video(s), voice, and likeness. The entrant hereby holds harmless and forever releases, discharges and indemnifies the New Jersey Lottery, Fuel Cycle, Inc. and Northstar New Jersey Lottery Group, LLC, and its/their respective agents, owners, operators, officers, directors, commissioners, elected officials, members, shareholders, contractors, subcontractors, employees, partners, and designees, and each of their respective parent companies, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers and advertising and promotion agencies, and any and all other companies associated with the New Jersey Lottery, Fuel Cycle, Inc. and Northstar New Jersey Lottery Group, LLC, from any and all liability, injury, damage, death, litigation, claim, cause of action, loss or demand, known or unknown, which the entrant, the entrant's heirs, agents, representatives, executors, administrators, or any other persons acting on the entrant's behalf or on behalf of the entrant's estate have or may have by reason of this Image Authorization, including without limitation, all claims for invasion of privacy, right of publicity, defamation, false endorsement, and any other claims regarding personal and/or

property rights. The New Jersey Lottery Law (N.J.S.A. 5:9-1 et seq. and N.J.A.C. 17:20-1 et seq.) allows the holders of winning New Jersey Lottery tickets or shares to choose to remain anonymous. This does not apply to promotions, sweepstakes or contests conducted through Game Changers, including this Game Changers Monthly Sweepstakes.

Waiver and Release of Liability: As a condition of entering the Sweepstakes, the entrant agrees to forever waive, discharge, indemnify and release the New Jersey Lottery, Fuel Cycle, Inc. and Northstar New Jersey Lottery Group, LLC, and its/their respective agents, owners, operators, officers, directors, commissioners, elected officials, members, shareholders, contractors, subcontractors, employees, partners, and designees and each of their respective parent companies, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers and advertising and promotion agencies, and any and all other companies associated with the New Jersey Lottery, Fuel Cycle, Inc. and Northstar New Jersey Lottery Group, LLC (collectively "Affiliates"), from any and all liability, injury, damage, death, litigation, claim, cause of action or loss that may occur, directly or indirectly, whether known or unknown, and whether caused by negligence or not, arising out of or associated with the entrant's participation in the Sweepstakes, the entrant's acceptance, possession, use or misuse of any Prize awarded in connection with the Sweepstakes, any defect with the Sweepstakes, and/or any error in the administration or operation of the Sweepstakes. The entrant, on behalf of him/her self, his/her spouse, heirs, executors, administrators, representatives, successors, assigns and next of kin, waive all claims for damages, injuries and/or death, whether known or unknown, and whether caused by negligence or not, sustained to the entrant or the entrant's property that the entrant may have against the New Jersey Lottery, Fuel Cycle, Inc. and Northstar New Jersey Lottery Group, LLC, and its/their respective Affiliates, arising out of or associated with the entrant's participation in the Sweepstakes, the entrant's acceptance, possession, use or misuse of any Prize awarded in connection with the Sweepstakes, any defect with the Sweepstakes, and/or any error in the administration or operation of the Sweepstakes.

Finalist Selection: Ten (10) finalists and ten (10) alternate finalists of the Sweepstakes will be randomly selected each month during the Sweepstakes Period by a computerized drawing of all entries submitted in compliance with these Official Rules. Finalists will be notified by email on or around the Notification Date set forth in the Sweepstakes Chart. Finalists must confirm their Claim Information and acceptance of the Prize in the manner required by the New Jersey Lottery or its designee within five (5) business days of initial contact from the New Jersey Lottery or its designee, and the failure of any finalist to do so will result in the disqualification of that finalist from the Sweepstakes and forfeiture of his/her Prize. In the event that a finalist is disqualified from the Sweepstakes, an alternate finalist will be notified, in order of his/her selection, that the alternate finalist has been selected to receive a Prize, and the alternate finalist will be required to confirm the required Claim Information and prize acceptance in the required manner and timeframe. As a



condition of entering the Sweepstakes, entrants agree that if they are selected as a finalist or alternate finalist, they shall provide complete, accurate and truthful information, including Claim Information, to the New Jersey Lottery or its designee.

The Prize will be sent to each verified winner in full compliance with these Official Rules by UPS to the address provided by each verified winner to the New Jersey Lottery or its designee. The New Jersey Lottery and Northstar New Jersey Lottery Group, LLC shall not be responsible for lost, undelivered or incorrectly addressed packages. Cash will NOT be awarded in lieu of Prize. Winners are solely responsible for payment of all applicable federal, State and local taxes associated with any Prize awarded in connection with the Sweepstakes. The New Jersey Lottery and Northstar New Jersey Lottery Group, LLC shall not be liable for an entrant's failure to receive a finalist selection notification for any reason including but not limited to the entrant's spam, junk email or other security settings or for an entrant's provision of incorrect or otherwise non-functioning contact information and/or Claim Information. As a condition of entering the Sweepstakes, entrant agrees that the New Jersey Lottery may, and entrant gives permission to the New Jersey Lottery and its designees to, publish entrant's full name, town and State of residence, and prize amount across the New Jersey Lottery's social media platforms and Website if entrant is a verified winner of the Sweepstakes.

Changes: Official Rules may be changed at any time and without prior notice if determined, in the sole discretion of the New Jersey Lottery or its designee, to be in the best interest of the New Jersey Lottery.

Disputes: The Sweepstakes is governed by the State Lottery Law, N.J.S.A. 5:9-1 through -25, and the Rules of the Lottery Commission, N.J.A.C. 17:20-1.1 through -12.23. The New Jersey Lottery Executive Director has the sole authority to resolve disputes. The New Jersey Lottery Executive Director's decision regarding any disputes shall be final.

Sweepstakes Integrity: The New Jersey Lottery or its designee reserves the right to cancel, terminate, modify or suspend the Sweepstakes for any reason, including but not limited to if it/they determine(s), in its/their sole discretion, that a virus, bug, unauthorized human intervention, fraud or other cause (the "Event") has or is corrupting or affecting the administration, security, fairness or proper conduct of the Sweepstakes. In such a case, the New Jersey Lottery or its designee, in its/their sole discretion, may select winners from all eligible entries received prior to or after resolution of (if appropriate) the Event. The New Jersey Lottery or its designee reserves the right, in its/their sole discretion, to disqualify any individual who tampers with or attempts to tamper with the entry process for the Sweepstakes, the operation of the Sweepstakes or otherwise violates these Official Rules. The New Jersey Lottery or its designee has the right, in its/their sole discretion, to maintain the integrity of the Sweepstakes and to void an entry for any reason, including the use of bots, macros or scripts or other technical means for entering.



Any attempt by an entrant to deliberately damage any system or program of the New Jersey Lottery or its designee, or to undermine the legitimate operation of the Sweepstakes in any way, may be a violation of criminal and civil laws. If such an attempt is made, the New Jersey Lottery or its designee reserves the right to seek compensation from any such person to the fullest extent permitted by law.

Severability; Waiver; Headings: The invalidity or unenforceability of any provision of these Official Rules will not affect the validity or enforceability of any other provision of these Official Rules. In the event that any provision of these Official Rules is determined to be invalid or otherwise unenforceable or illegal, in whole or in part, the other provisions will remain in full force and effect and will be construed in accordance with their terms as if the invalid or illegal provision were not contained therein. The headings used in these Official Rules are for convenience only and shall not affect the interpretation of any of the provisions of these Official Rules. The failure to enforce any provision of these Official Rules will not constitute a waiver of that or any other provision of these Official Rules.
